The Corporation, in turn, shall issue a receipt which is to be uploaded through e-tender portal.
- 3. No request for extension of time beyond schedule hours for submission of bid shall be entertained.
- 4. Prospective bidders were requested to submit hardcopy of technical bid in sealed cover by last date & time of submission of bid.
